Through a contract with the State Board of Education, Washington Park Community School is held accountable for meeting agreed-upon goals and standards set forth by the State of Ohio and the school's sponsor.

About Our Students

Washington Park Community School permits the enrollment of students who reside in any district in the State of Ohio. Those students who are currently enrolled are ensured a space for the following school year if they enroll during the two-week open enrollment period. If there are more students who apply than there are spots available, a lottery is held, and a wait list is created.

Student Performance Data Analysis

The student performance data indicates that testing results are below the proficient range. Determining factors may apply:

- 1. 44% of the teaching staff in 2021-2022 were certified and/or highly qualified
- 2. During the months August through December, none of the teachers in grades 4-8 were certified and/or taught under a substitute license.
- 3. Closing the academic achievement gap in all grades became a significant priority. Due to online learning, and COVID-19, the achievement gap widened and more instructional time was spent on teaching the essential standards in order to catch up to grade level learning norms.
- 4. Staff turnover including teachers, secretary, and assistant principal positions affected the first half of the school year. Once filled, training and ensuring proper expectations were a focus to ensure safe and efficient building operations were in place.

For the 2022-2023 school year, the CSLT determined that the school will focus on the following academic and non-academic goals to improve student achievement:

- 1. Analyze the school's tier 1 curriculum. Focus on using learning programs and materials that are researched based and proven high effective outcomes.
- 2. Use high quality student data to determine and diagnose students' strengths and weaknesses.
- 3. Provide extended learning opportunities for students to help close the achievement gap. This includes after school tutoring and summer school.
- 4. Provide opportunities for professional development to teachers and staff to implement instructional strategies with success and provide effective instruction in tier 1.
- 5. Extend all ELA and math instruction to 90 minutes grades K-8.
- 6. Focus on providing additional support to key student subgroups who scored significantly lower compared to white students. Subgroups include: students who are Black, Hispanic, and have learning disabilities (supports include extended learning after school, increased communication with families and students outside of the classroom, and provided additional materials and/or resources that will engage and enhance student learning at home and in the classroom).
- 7. Create opportunities to demonstrate and celebrate growth and improvement in the areas of academics, attendance, and student behavior; focusing on the whole child.
- 8. Prioritize and embed social emotional curriculum and support to students and staff.

2021-2022 Financial Report

The Washington Park Community School maintains a healthy financial outlook with a carryover to guarantee continued operation. Community schools can only receive funding from state and federal sources and cannot impose levies or obtain independent local funding. This means we must maintain strict control over expenditures.

This year there have been major improvements to the school building through funding provided by the federal government through the ESSER grant. We replaced old, damaged glass block windows with new glass block windows, each with a small window opening to enable fresh air to come into the room when desired. We also replaced outside doors to better secure the building and control who was able to enter. Our largest ESSER project was the removal of old stained carpeting throughout the building and replacement with easy care, sanitary floor covering. We also made major improvements to the HVAC system to provide safe ventilation in all classrooms. One classroom's new ventilation system was funded through a grant by the Ohio Bureau of Workers' Compensation. We have upgraded our school website and provided new technology to each student.

This year the school updated our financial software to be in alignment with new state upgrades. Each year we are audited by the Auditor of the State of Ohio or his agents. Our audits have always been determined to be clean, with all procedures determined to be in keeping with best financial practice.

Sponsor Statement

St. Aloysius, as the sponsor of this school, is legally mandated to provide oversight, monitoring, and technical assistance. As part of the monitoring process, the performance of the school is assessed and evaluated on each of the required Ohio School Report Card components. Additionally, St. Aloysius has a regular presence at school board meetings where student performance indicators such as attendance, behavior, and academic achievement are tracked and financial and organizational issues that impact student success are reviewed and discussed. Key to the oversight, monitoring, and technical assistance is St. Aloysius' review of the school's Ohio Improvement Process (OIP) plan development and implementation. As a result of our thorough oversight and monitoring, St. Aloysius has determined that this school is substantially compliant with the rules and regulations governing community schools.

All community school sponsors are required to submit a written report of the evaluation results of the school's academic, financial, and organizational performance, as well as the school's legal compliance with Ohio Revised Code, Ohio Administrative Code, and to the terms of the Community School contract. This report must be made available to parents of students enrolled in the community school by November 30th of each year under OAC 3301-102-05 (A) (3).
